<u>DID YOU KNOW</u>.....Requirements for being a business owner in town do not stop when you obtain a business license!

Business Licenses need to be renewed annually by March 1. Additionally, if you have any signs (building mounted, window signage, free-standing, sandwich boards, etc.), plan to expand, or wish to start a home business, you will need a permit. Regulations are outlined in the Town of Strasburg's Unified Development Ordinance. Stop by the Town Hall, phone 540-465-9197, or email the town's Planning Pearson Administrator Wyatt Zoning (wpearson@strasburgva.com) or **Economic** Development & Marketing Manager Michelle Bixler (mbixler@strasburgva.com) if you have any questions about whether or not you are in compliance with the regulations. We are here to help you better prepare for your changes and we also have business resources to share.

#### **FY2017-18 BUDGET PREPARATION**

The Finance Department is beginning to work on the FY 2017-18 Budget. Department Directors have submitted their estimated expenditures for the coming year and revenue projections are being calculated. Listed below is the tentative calendar for the budget process. Citizens are invited to all meetings to learn more about the budget process and offer input.

#### **FISCAL YEAR 2017-18 BUDGET CALENDAR**

**February 6, 2017, 7 p.m.** – Work Session: Discuss major budget factors

*March 6, 2017, 7 p.m.* – Work Session: Review scenarios with Council

*April 3, 2017, 7 p.m.* – Work Session; Review draft budget

May 1, 2017, 7 p.m. - Work Session, if needed

*May 9, 2017, 7 p.m.* – Public Hearing on FY2017-18 Proposed Budget

June 13, 2017, 7 p.m. - Council meeting; adopt FY2017-18 Budget

#### JUST A REMINDER.....

If you have recently sold or traded a vehicle or if you have moved either out of or into the Town of Strasburg, please contact the Shenandoah County Commissioner of Revenue's office at 540-459-**6170**. Notifying this office of any changes to vehicles you own will help ensure your personal property taxes are correct. Please be aware that you will be billed the entire year for any vehicle owned on January 1st of the tax year; the Town, as well as Shenandoah County, does not pro-rate taxes. The Town of Strasburg receives all tax information from Shenandoah County so Town Staff cannot change tax records without prior notice from the county. Even if you have changed your information with DMV, it is a good idea to notify the Commissioner's office.

Also, if you have recently changed your phone number, please let the Town Office know. This helps Town Staff keep records up-to-date.



### ORDINANCE CHANGE SECTION 82-8 OF THE TOWN CODE

The Strasburg Town Council passed changes to the Town Code pertaining to bicycles, skateboards, and other wheeled devices on the streets. The adopted Code change reads:

Sec. 82-8. – Sidewalk and crosswalk zones where bicycles, skateboards and other devices on wheels or runners prohibited.

- (a) Generally. No person shall ride a bicycle, roller skates, skateboard, toy or other device on wheels or runners on or across a sidewalk, roadway or crosswalk where such use of bicycles, roller skates, skateboards, toys or other devices on wheels or runners is prohibited by designation in this section and where signs indicating such prohibition have been conspicuously posted in the zones where such use is prohibited.
- (b) Prohibited zones designated. The streets, sidewalks, and portions of streets designated as "prohibited zones" in this section shall be as follows:
  - (1) King Street, between Capon Street and Acton Place
  - (2) Massanutten Street, between Washington Street and King Street.
- (c) As an exception to the foregoing provisions, bicycles may be operated in accordance with all traffic regulations applicable to motor vehicles, on any street in the Town of Strasburg.
