

# Process and Supplementary Information:

Only fully complete applications will be accepted and reviewed by the Zoning Administrator. Criteria for application completeness varies by the type of request. Therefore, below is an unofficial guide. For full details and official information please refer to the Unified Development Ordinance (UDO) available at the Town Office or website, or call the Town Office and ask to speak with the Zoning Administrator.



- Variance: Applicant requests alteration to regulations due to extraordinary hardships brought about by strict compliance with these regulations.
  - □ <u>Survey plat</u> of the property, prepared by a licensed professional surveyor, showing all existing and proposed structures and indicating the area of the property to which the variance applies.
  - ☐ <u>A detailed description</u> of why the Variance is being applied for, and how the application is in accordance with UDO 2.18.4 Findings and Conditions.
- **Exception (modification):** Applicant requests a minor alteration to regulations due to exceptional circumstances.
  - □ <u>Survey plat</u> of the property, prepared by a licensed professional surveyor, showing all existing and proposed structures and indicating the area of the property to which the Exception applies.
  - ☐ <u>A detailed description</u> of why the Exception is being applied for, and how the application is in accordance with UDO 2.43.4 Approval Criteria.
  - □ <u>Certified mail receipts</u> and a copy of the letter mailed to adjacent property owners.

• Administrative Appeal: Any aggrieved person may appeal a decision of any employee of the Town of Strasburg pursuant to application or enforcement of the UDO.

- ☐ <u>Mail this application and/or a letter</u> to the Board of Zoning Appeals, C/O the Zoning administrator, and Town Clerk.
- $\Box$  <u>Application fee</u> of \$325 must be paid upon filing of appeal.
- **Planning Commission Appeal:** Final decisions by the Planning Commission may be appealed to Town Council.
  - ☐ <u>Mail this application and/or a letter</u> to the Town Council, C/O the Zoning administrator, and Town Clerk.
  - $\Box$  <u>Application fee</u> of \$325 must be paid upon filing of appeal.
